AMENDMENT NO. 1 TO THE CONNECTED CORRIDORS I-210 PILOT

PROJECT CHARTER

This Amendment No. 1 to the Connected Corridors I-210 Project Charter ("Amendment") is made by and between the California Department of Transportation – Headquarters ("CT HQ"), the California Department of Transportation District 7 ("CT D7"); the Los Angeles County Metropolitan Transportation Authority ("LA Metro"); the Los Angeles County Department of Public Works ("LACDPW"); the City of Pasadena ("Pasadena"); the City of Arcadia ("Arcadia"); the City of Monrovia ("Monrovia"); the City of Duarte ("Duarte"); the University of California, Berkeley Partners for Advanced Transportation Technology ("UCB PATH"); the Southern California Association of Governments ("SCAG"); the San Gabriel Valley Council of Governments ("SGVCOG"); and Foothill Transit ("FT"); collectively the "Core Stakeholders."

1. BACKGROUND

- A. On June 25, 2015, the Core Stakeholders executed the Project Charter which established a mutual understanding regarding the Connected Corridors I-210 Pilot in the San Gabriel Valley ("Project"). It defined the roles and responsibilities for planning and implementing the initial phase of the project.
- B. While it was initially envisioned that the next agreement would be a Memorandum of Understanding, the Core Stakeholders have opted to execute this Amendment No. 1 to the Project Charter. The original Project Charter states: "The Project Charter will be valid for eighteen (18) months from its execution, or until an MOU is fully executed, whichever period of time is shorter."
- C. Since the end of 2014, the following documents have been drafted, reviewed by the Core Stakeholders, revised, and approved:
 - i. Concept of Operations 6.15.15
 - ii. Project Management Plan 9.17.15
 - iii. Systems Engineering Management Plan 9.17.15
 - iv. Analysis, Modeling, and Simulation Report Phase 1 9.17.15
 - v. I-210 Pilot System Requirements October 2016
- D. The Project has received funding from the following sources:
 - i. State Highway Operation and Protection Program (SHOPP) \$24.8M
 - ii. LA Metro 2015 Call for Projects \$6.45M

2. THE CORE STAKEHOLDERS NOW DESIRE TO AMEND THE PROJECT CHARTER AS FOLLOWS:

- A. The following Primary Contact Persons shall be updated as follows:
 - i. Caltrans District 7 Morteza Fahrtash
 - ii. Metro Operations Bruce Shelburne
 - iii. SGVCOG Phil Hawkey, Executive Director

- iv. SCAG Naresh Amatya, Acting Director, Transportation Planning
- B. The Core Stakeholders will, in a timely manner, review and approve the design documents, and other documents to be determined.
- C. LACDPW, Pasadena, Arcadia, Monrovia, Duarte, and Foothill Transit are receiving infrastructure and/or software improvements as part of the LA Metro 2015 Call for Projects funding. These agencies agree that the improvements, while installed by CT D7 (the Project Sponsor), will be owned, operated, and maintained by LACDPW, Pasadena, Arcadia, Monrovia, Duarte, and Foothill Transit respectively. Separately, the agencies will work with CT D7 to execute an "Asset Transfer Agreement" or similar document that outlines the improvements in each jurisdiction.
- D. CT D7 agrees to 24 hours per day/7 days per week corridor/asset monitoring from the Los Angeles Regional Transportation Management Center (TMC) near Glendale, CA.
- E. The Core Stakeholders agree to execute additional agreements for various aspects of the Project including, but not limited to, an Operations and Maintenance Plan, a System Integration Plan, and a Memorandum of Understanding.
- F. Core Stakeholders will now include LA SAFE (the Los Angeles County Service Authority for Freeway Emergencies) and RIITS (the Regional Integration of Intelligent Transportation Systems program).
 - i. LA SAFE includes the SoCal 511 Traveler Information System, and the Kenneth Hahn Call Box System.
 - ii. LA Metro administers RIITS with information provided from government agencies in Southern California and other sources of transportation data available through RIITS.
 - iii. Additional Core Stakeholders may be added without amendment to the Project Charter with verbal approval of Caltrans, LA Metro, PATH, LA SAFE, LA County and the cities (Pasadena, Arcadia, Monrovia, and Duarte).
- G. The Project Charter will expire December 31, 2018.
